- 27 DR: I done told ya'. I done told ya' brotha. You know and he keeps that recorder going, I'mma
- 28 tell you. That's what I told Don yesterday...when D'Angelo...I said listen Don...this boy is so
- 29 damn desperate he's recording everything! Everything! But I don't have no problem wit it.
- Cause I tell him, what I say to you and how I put it to you is, you know, its politically and 30

- 6 this cracker is recording your conversations." I don't care how small, how minute, it will be
- 7 construed as and could be construed as look he's trying to make deals. He's trying to cut deals.
- 8 **AM:** Mmmh mmh.
- 9 **DR:** You know? And instead of just taking a position, I can't do that, I can't talk to you about
- 10 that and just hang up the phone and be done. When you call him back and the timer kicks on and
- the date and timer kicks on and all of that, so...
- 12 AM: You better believe it. Cause they got sophisticated equipment out there these days.
- 13 **DR:** Sure they do!
- 14 **AM:** And he have it. He have it.
- DR: Well, I...when I tell him something. I'm not just dreaming shit up. I ain't making shit up. I

- to the end like this. His political judgment about black folk are really really far off the mark. Far
