Sorry for the delay Mr. Fisher. Just to let you know of my situation, I am having a problem meeting my financial needs. I attend Grambling State University in Grambling, La (40min east of Shreveport) getting a Masters of Science in Sport Administration. I do not have a vehicle to go to school so I walk 20 minutes to go to class and home. My parents are unable to help me. My dad has a disability (he has had two strokes) and my mother quit her job to take care of him. There income is my dad's social security check which doesn't equate to anything. I am currently trying to apply for food stamps but the waiting list is 3 weeks. I have an apartment payment along with electricity, gas, light, and water bills. With no vehicle, it is difficult to get a job. I am on work-study with my department however, it pays 250 and month for 40 hours (equal to about \$6/hour). Mr. Fisher, I would be very grateful if you were to send me any amount. Mr. Lee has been a positive influence in my life and I thank him for giving me the opportunity to speak with you sir.

Talking with the Director of Grants/Development at Grambling State University, Dr. Island, says that if you are sending money to me that it would be best if you send it directly to me and not the university. If you were sending a check directly to the university, then that would be a time you can do that, but if the money is for me then to just mail the donation to me. Mr. Fisher,

Just to follow up on my previous email:

I am requesting for \$5,000 for the following:

My monthly payment for my apartment is 375/month Utilities (gas, lights, water) is about 150/month Food is about 80/month Tuition is 3360/semester (I signed a promisory note to the university (pay 50% now and the other 50% before the semester is over)

$\$375 * 12 = \4500

$\$150 * 12 = \1800

$\$80 * 12 = \960

3360 divided by 2 = \$1680

All of that added up is = \$8940

Like I said previously that I do work study for \$250.

$\$250 * 12 = 3000$

$\$8940 - \$3000 = \$5900$

Also, books for class is equal to about 250/semester.
