

1 D'ANGELO LEE (LEE): MS. FARRINGTON?
2 SHEILA FARRINGTON (FARRINGTON): MR. LEE. SIR LEE.
3 LEE: Where were you?
4 FARRINGTON: Where were, where am I?
5 LEE: Where, yes.
6 FARRINGTON: I'm just leaving the office.
7 LEE: Okay. I, I had to go make a run real quick,
8 but I was on my way up there, umm, you got to come pick up
9 S [REDACTED]
10 FARRINGTON: Yeah.
11 LEE: Okay. Well, after...
12 FARRINGTON: I can, I can pick her up and, and drop
13 her off and come back.
14 LEE: Okay. Well do that. 'Cause I just, I just got
15 a check I need to give you. Have you ahh, have you,
16 ahh, invoiced SOUTHWEST HOUSING?
17 FARRINGTON: Yes.
18 LEE: You did?
19 FARRINGTON: Yes.
20 LEE: Have you talked to 'em?
21 FARRINGTON: Yes.
22 LEE: Is it ready?
23 FARRINGTON: It should be ready tomorrow.
24 LEE: Okay. Okay, ahh, did you, did, did ahh, were

1 you able to, did you transfer that stuff to the other
2 account,
3 or you just gave it to her?
4 Or you never have given it to him yet?
5 FARRINGTON: Okay, say that again.
6 LEE: The security stuff, did you transfer it to your
7 letterhead, or you gave it to him on the letterhead
8 that you got from him?
9 FARRINGTON: I have, ahh, I haven't gotten it yet.
10 LEE: Okay. (UI) let me know...
11 FARRINGTON: Soon as I get it then, then, of course,
12 I would never just turn it over to him with his...
13 Laughing...
14 A lot of screeching noise
15 FARRINGTON: Let us have a blast at it. I mean this looks
16 crazy so.
17 LEE: Well, call me soon as you...
18 FARRINGTON: I thought you was just calling because
19 you were my friend, and you just wanted to also, and
20 say, hi friend, how are you, friend?
21 LEE: Well...
22 FARRINGTON: You, you just wanted to call me to...
23 ...okay fine.
24 LEE: (UI) I, (UI)....in a couple of days. The last

1 time I talked to you was Monday. You, I was supposed
2 to see you at the golf tournament. I haven't seen
3 you since.

4 FARRINGTON: Yeah, I know.

5 LEE: Or talk to you. I said, okay, maybe she's
6 going through something...

7 FARRINGTON: Oh, no. You know what, all these
8 questionnaires? All these ahh, candidate forum
9 questionnaires?

10 LEE: Mm-hmmm.

11 FARRINGTON: He don't fill 'em out, I have to.

12 LEE: (UI)

13 FARRINGTON: And they, they want you, they want you
14 to reform the whole government on a piece of paper.

15 Laughing...

16 LEE: (UI)

17 FARRINGTON: I don't know how you supposed to do that.

18 LEE: And then, and then file it away, huh?

19 FARRINGTON: Huh?

20 LEE: And then they file it away, ahh, once they,
21 you know. (UI)

22 FARRINGTON: Yeah. I know it.

23 LEE: How did he suggest it?

24 FARRINGTON: That's what I said. That's what we
25

1 spend all this time, all these hours on this. Giving
2 it great, you know, thought, and carefully putting it
3 together and then they just toss it when it's over.
4 LEE: Well, okay, well I'll take you (UI). Pick it
5 up. I feel you. I feel you.
6 FARRINGTON: But, he had one with, ahh, DALLAS
7 MORNING NEWS this morning, and that's the one that had me
8 caught up
9 on Monday. And ahh, ahh, his, both of his, both of
10 his opponents were there.
11 LEE: Okay.
12 FARRINGTON: And it was like, uh, a candidate forum
13 kinda situation, and ahh, I, I don't know how they can...
14 LEE: Oh.
15 FARRINGTON: ...articulate, huh?
16 LEE: This is what I wanted to tell you. This is
17 what I wanted to tell you. And you, you need to mention
18 this
19 to Don. Tomorrow, there's gonna be some type of
20 Congressional meeting with the VA tomorrow, at the VA.
21 FARRINGTON: Mm-hmmmm.
22 LEE: And we want to be able to talk about the SRO
23 there.
24 FARRINGTON: Okay.
25

1 LEE: At that meeting. EDDIE BERNICE JOHNSON
2 supposed to be there and ahh, ahh, a bunch of, a lot
3 of Congressional people 'sposed to be there...
4 FARRINGTON: Okay.
5 LEE: ...tomorrow. So, you need to run some
6 interference on that and ahh you need to be, you know
7 see if he could, you know, set up a way we can meet.
8 I'll go with you, or he and I'll go, and you, you and
9 I go. Or you go, or somebody to, you know, just in,
10 you know, to at least voice the SRO.
11 FARRINGTON: Right.
12 LEE: You know? Being a part of that, so just
13 mention it to him that they're, they're gonna be, meet
14 at the VA, and have him have GLENDA, to let them know
15 that, that a representative from his office will be there.
16 FARRINGTON: Mm-hmmm.
17 LEE: You know, at that meeting?
18 FARRINGTON: Okay.
19 LEE: Alright?
20 FARRINGTON: I can do that.
21 LEE: Okay, well, let me ahh, I'm gonna change, I've
22 been (UI) I'm gonna change and, and I'm kinda tired,
23 need to lay down. But I'm, I'm coming right back out
24 so. As soon as you pick up S [REDACTED] call me.

4 well.

5 LEE: Oh, okay, that's cool. I'm going, 'cause I'm
6 gonna pick me up one, I could get 'em, but, you know,
7 buy one. They sell 'em, but it's like a hundred bucks.

8 FARRINGTON: Yeah.

9 LEE: And I don't know if I really wanta pay a

7 LEE: All (UI).
8 FARRINGTON: ...hey, he working it anyway.
9 Laughing...
10 LEE: He was acting, he, he was working like, he knew
11 like, you know, he'd been having it all the while.
12 FARRINGTON: Laughing...
13 LEE: Like, like you wouldn't know how to answer the
14 phone without it. I just never knew how I existed
15 without this (UI).
16 FARRINGTON: Laughing...

18 That,
