

1 The following is a transcript of a conversation
2 between JAMES R. FISHER (also known as BILL FISHER)
3 and RICK ROBERTSON on February 9, 2005:
4 BILL FISHER (FISHER):Talking into
5 recorder. Uh, it's, uh, BILL FISHER. It's ten-
6 fifty-eight on the ninth and I'm getting ready to
7 call RICK ROBERTSON.
8 Telephone rings three times
9 RICK ROBERTSON (ROBERTSON):MILLENNIUM.
10 FISHER:Hey, RICK.
11 ROBERTSON:Yeah.
12 FISHER:BILL FISHER.
13 ROBERTSON:How you doing?
14 FISHER:I'm just fine. Are you where you can talk?
15 ROBERTSON:Yeah, go ahead.
16 FISHER:I talked to JIBREEL earlier, he was looking to
17 track you down and, uh, try and get a meeting
18 scheduled here, you know, on short notice. Have you
19 heard from him?
20 ROBERTSON:Yeah, he called me, uh, probably about
21 fifteen minutes ago and he said he was gonna call me
22 back after he spoke with you and, uh, UI...
23 FISHER:Yeah, he hadn't, he, he hadn't called me. So,
24 um, you know, what's your game plan at this point?
25 ROBERTSON:Uh, me see here, um, I mean, we can get

1 together, um, it'd probably be, where are you now?
2 FISHER:I'm at my office right now, but I was getting
3 ready to head out for a quick meeting, so, um, tell,
4 tell me what you all had in mind.
5 ROBERTSON:Um, well, I mean, if you wanted to meet
6 and, and, and, you know, and, and, and do what we
7 discussed last night, that's fine. I mean,
8 everything is, like I said, everything is, is on
9 point, so, you know.
10 FISHER:So, you're saying everything's teed up here,
11 um, for this afternoon?
12 ROBERTSON:Yeah. I mean, everything is, is, is, is, I
13 mean, basically, it's, it's in your court like we
14 said last night. So, we, we, we, we, waiting on you,
15 we was waiting on you to call this morning and, you
16 know, and just, you know, come with your end of the
17 bargain.
18 FISHER:You know, the, uh, the, you know, I told
19 JIBREEL this morning, you know, the problem I'm
20 having is that DARREN is telling me that the case is,
21 is being held and DON has already called my attorney
22 and told him that the case was gonna be held, I
23 mentioned that to you guys last night. Any, any
24 chance you can get DARREN to call me and tell me
25 that, you know, we're all together on the same page

1 here?

2 ROBERTSON:Nah, yeah, let me, let me put a call into

3 him and then, uh, and then I'll have him to call you.

4 FISHER:Yeah, 'cause originally, you know, again, I

5 had this conference call with he and D'ANGELO after,

6 uh, they met and...

7 ROBERTSON:Right.

8 FISHER:...they made it clear that everything was

9 supposed to go through DARREN. Like I said, DARREN

10 gave me a pretty good, uh, uh, chewing yesterday and,

11 uh...

12 ROBERTSON:Mm-hmm.

13 FISHER:...you know, frankly told me the case was

14 gonna be postponed and then of course then we get a

15 call an hour later saying it is being postponed,

16 so...

17 ROBERTSON:Mm-hmm.

18 FISHER:...um...

19 ROBERTSON:Okay, so, yeah, I'll, I'll, I'll, I'll put

20 in a call to DARREN and then have him to call you.

21 FISHER:Yeah, have him, have DARREN call me.

22 ROBERTSON:Okay. Alright.

23 FISHER:Alright.

24 ROBERTSON:Yeah.

25 FISHER:Bye.

1 Callers hang up
2 Talks into recorder
3 UI. That was, uh, RICK ROBERTSON. It's, uh, eleven
4 o'clock.
