The following is a transcript of a telephone conversation between D'ANGELO LEE and ANDREA SPENCER on March 1, 2005, telephone number (214) 729-3484, at approximately 1639 hours:

D'ANGELO LEE (LEE): Yeah?

ANDREA SPENCER (SPENCER): Okay, sorry about that.

LEE: Uh huh.

SPENCER: I'm going to be pulling off. I'm coming down thirty. I had to make a detour to go pick up some checks. Some money.

LEE: Hold on for a minute. Hold on. Okay.

SPENCER: Yeah, I wanted to go pick up those checks. The checks.

LEE: Okay. Were they ready?

SPENCER: Yeah. Yeah, it was ready.

LEE: Okay, okay.

SPENCER: So, just trying to get an up-to-the-minute report of seven and eight. We poured eight today. And, ah, if you know, it's suppose to rain tomorrow, so we'll have to wait and see if he's gonna be able to pour nine tomorrow or Thursday, so we'll see. But I needed to let, you know, RON know that we need to get on a conference call in the morning with the engineer about the box culvert issue and some of that drainage,

2 LEE: Yeah, and we're gonna call up to City Hall to  
3 talk to, ah, JERRY. How much is, how much is the  
4 check?

5 SPENCER: Fifty four.

6 LEE: Fifty four?

7 SPENCER: Uh huh.

8 LEE: This thing (UI) it all. We need to deposit it.  
9 They'll probably put a hold on it.

10 SPENCER: They probably will. You don't need that.

11 LEE: On a ten day.

12 SPENCER: You probably right. Unless we can go over  
13 there and find the bank and then...

14 LEE: (UI)

15 SPENCER: Go get us a cashier's check. Ah, TEXAS  
16 CAPITAL BANK.

17 LEE: That's in his building.

18 SPENCER: That's where?

19 LEE: That's in SOUTHWEST HOUSING's building.

20 SPENCER: Well, you know what? They can probably RON  
21 can meet me up there in the morning and just let them  
22 transfer it into a cashier's check.

23 LEE: Yeah, yeah. And I think we need to have ah, a,  
24 ah, a, we haven't had a money discussion.

25 SPENCER: About what? I mean, just general.

1 LEE: Yeah, just in general. How we...

2 SPENCER: Yeah.

3 LEE: How we do things when checks come in and (UI)

4 You know, (UI) and what's going to get paid and what's

5 gonna wait over and things of that nature so. I put

6 some thought to it, uhm.

7 SPENCER: Well, just know that. Well, I know you know

8 that. But RON got a whole bunch of money out there.

9 LEE: I understand that, too.

10 SPENCER: On (UI). So, we got rent to get paid

11 tomorrow.

12 LEE: (UI) got a lot of credit out there.

13 SPENCER: So.

14 LEE: We'll, we'll work it out. It's going get, it'll

15 get paid real soon.

16 SPENCER: So, uhm, anyway... So, I'm, I'm getting

17 ready to pull up here in a minute. I'm on Industrial

18 and ready to turn on (UI).

19 LEE: Yeah, I just, I just took all that food over to

20 the, ah, to the shelter.

21 SPENCER: That's really no good. It's been sitting in

22 your car all day.

23 LEE: Yeah cause I need (UI) I said look, take this

24 over to the shelter and leave it there. All right.

25 I'll see you when you get here. 'Bye.

1 SPENCER: 'Bye, 'bye.
