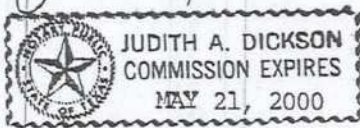

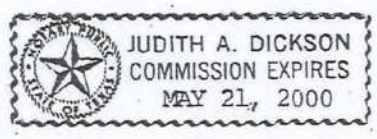

STATEMENT OF OFFICER FAX GUIDELINES

INSTRUCTIONS

1. Provide all requested information in a legible manner.
2. Members of the Legislature and all other elected officers shall file the signed statement...with the Secretary of State before taking the Oath or Affirmation of office...
[Texas Constitution, Article XVI, Section 1(e)]
3. All oaths, affidavits, or affirmations made within this State may be administered and a certificate of the fact given by:
 - a. A judge, clerk, or commissioner of any court of record;
 - b. A notary public;
 - c. A justice of the peace or a clerk of a justice court;
 - d. Any member of any board or commission created by the laws of this State, in matters pertaining to the duties thereof;
 - e. The Secretary of State of Texas;
 - f. An employee of the Secretary of State of Texas who has duties related to the reports required by Title 15, Election Code, in matters pertaining to those duties;
 - g. The Lieutenant Governor of Texas;
 - h. The Speaker of the House of Representatives of Texas; and
 - i. The Governor of Texas.
 [Tex.Rev.Civ.Stat.Ann., art. 26 (Vernon Supp. 1990)]
4. Case law indicates that "filing" occurs when the instrument that is to be filed is placed in the custody or control of the person or office where the instrument is to be filed, except where otherwise defined by law. Therefore, the statement of officer is considered "filed" once this office actually receives the document.

As of 08-01-92 the Office of the Secretary of State will accept facsimile (FAX) filing of the signed statements required by Tex. Const. art. XVI, § 1. This will eliminate the need to file the original document. *However, only properly executed legible documents will be accepted.* These guidelines should assist you in accomplishing FAX filing pursuant to 1 TAC §§ 73.43 and 73.44.

THE FORM

Only forms which contain the same information requested on the Secretary of State promulgated form will be accepted for facsimile filing. Our form requires: 1) the officer's legibly printed or typed name; 2) the Constitutional language for the position (i.e., appointed or elected); 3) the officer's signature; 4) the office elected or appointed to; 5) the city or county in which the office is located; 6) a notarial certificate; and, 7) the printed name, signature and title of the person administering the oath. We will accept any FAXed form which incorporates these elements.

BASIC POINTERS

If any information is illegible or missing, the FAXed form will not be accepted. Certain well known abbreviations will be accepted (i.e., ISD, Cisd, CED, MUD, FWSD, WCID, etc.).

If the office is a city office (Mayor, Alderman, etc.), there is no need to include the county name. Alternately, if the office is a county office (Sheriff, Commissioner, Clerk, etc.) there is no need to include the city name. If you're not sure, give us both.

If the office is that of a district's director, supervisor, etc., include the name of the district (i.e., Director, Big City MUD #1; Supervisor, Hoover Dam Water Authority; Administrator, Medical Center Hospital District; etc.).

The seal of the person administering the oath should be visible. If the person is a notary public, Tex. Gov't Code Ann. § 406.013 (Vernon 1990) requires that the seal be affixed in a way "that legibly reproduces the required elements of the seal under photographic methods".

FAXING

The proper telephone number to which one should FAX Statement of Officer forms is (512) 463-0873. Please do not use any of the other Secretary of State FAX numbers for this filing. This FAX number remains on after business hours and on weekends.

FOLLOW-UP

This office does not automatic notification of filing. We will not FAX confirmation of filing. We will call you if there is a problem with our reception of your FAX.

Should you wish to have something for your files, we suggest that you mail us a self-addressed, stamped envelope (SASE) and a copy of your document, along with a note explaining your wish to receive a file-stamped copy. We will file-stamp the copy with the date the FAX was received and return it to you promptly.
