SPECIAL ORDER NO. 3-286

Effective June 20, 2011, the civil cases assigned to United States Magistrate Judge Philip R. Lane that are listed on Attachment A are reassigned to United States Magistrate Judge Nancy M. Koenig and shall henceforth carry the suffix letters "BG." All remaining civil cases assigned to United States Magistrate Judge Philip R. Lane are reassigned to United States Magistrate Judge E. Scott Frost and shall henceforth carry the suffix letters "BL." The magistrate judge to whom a case is assigned under this order is directed to seek the consent of the parties to conduct all further proceedings in the case and to order the entry of final judgment in accordance with 28 U.S.C. § 636(c). If all parties do not consent, the magistrate judge shall, unless the assigned district judge otherwise orders, exercise all powers permitted by 28 U.S.C. § 636(b).

All magistrate judge and petty offense cases assigned to Magistrate Judge Lane are reassigned to Magistrate Judge Frost and shall henceforth carry the suffix letters "BL." All remaining matters preliminarily assigned to Magistrate Judge Lane are preliminarily assigned to Magistrate Judge Frost.

All matters referred to Magistrate Judge Lane are referred to Magistrate Judge Frost unless otherwise directed by the presiding district judge.
